- · Share information on know-how of projects hosted by each party aimed at promoting tourism and attracting visitors.

This LOI shall have a validity period of two (2) years, which will be effective from the date of signing on this 30<sup>th</sup> day of November, 2018.

It is expressly understood that this LOI is NOT a legally binding document, and there is NO obligation to be complied with by either of the parties concerned.
