

**JOINT STATEMENT
BETWEEN
WAKAYAMA PREFECTURAL GOVERNMENT OF JAPAN
AND
DIRECTORATE GENERAL OF INDUSTRIAL RESILIENCE AND INTERNATIONAL
ACCESS DEVELOPMENT, MINISTRY OF INDUSTRY OF THE REPUBLIC OF
INDONESIA
ON
TECHNICAL COOPERATION AND INDUSTRIAL DEVELOPMENT**

1. Director General of Planning Department, Wakayama Prefectural Government and his delegation, paid an official visit to Jakarta on 11 October 2017 and met the Director General of Industrial Resilience and International Access Development of the Ministry of Industry of the Republic of Indonesia;
2. Director General of Industrial Resilience and International Access Development, Ministry of Industry of the Republic of Indonesia, expressed his high appreciation for the visit of the Director General of Planning Department, Wakayama Prefectural Government and his delegation;
3. While recognizing the huge potential of bilateral industrial development and technical cooperation between both Parties, Directorate General of Industrial Resilience and International Access Development and Wakayama Prefectural Government showed their willingness to further enhance the relationship between both Parties of industrial communities and encourage them to explore business opportunities. In this regard, both institutions shared the same view of the importance of developing working programs between interested industrial communities to achieve mutual benefit among them in both Parties.
4. Both Parties expressed their confidence to strengthen the bilateral cooperation to a higher level through mutual industrial development and mutual exchange of information in the fields of industries on the basis of equality, reciprocity and mutual benefit for both Parties, taking into account their respective capacity;
5. In order to further strengthen cooperation, both Parties have agreed to include the scopes as follows in good faith through :
 - a. Exchange of information in the field of industrial development and technical cooperation;
 - b. Explore the possibilities of organizing the joint activities such as jointly organizing seminars/and exhibitions to promote opportunities for industrial development and technical cooperation;

- c. Encourage their national entrepreneurs to participate in international fairs/exhibitions and business matching held in each country to promote technical cooperation of industrial sector;
 - d. Promote the exchange of business missions and facilitate the business matching programs for the visiting delegations.
 - e. Exchange of knowledge and expertise to benefit from the experience of both Parties in the field of human resource development, especially in dispatching technical assistance;
 - f. Other areas agreed upon by both Parties, in any future legal instrument.
6. In order to implement the scopes, containing at point 5 (five), both Parties agreed to make an implementing arrangement.
